- 5. If you are writing a Business or Personal Check- You <u>MUST</u> have a <u>PROOF OF AVAILABLE</u> <u>FUNDS OR LETTER WITH CHECK/S with REGISTRATION FORM.</u> Proof of Funds can also be a screen print, copy of statement, or show clerk on phone w/Forms.
